THE INSTITUTE HELD A NUMBER OF PUBLIC PANELS AND CONFERENCES TO ADDRESS THE MANY ISSUES OF IMPORTANCE TO THE UNITED STATES AND THE GCC COUNTRIES CONCERNING NATIONAL SECURITY, DOMESTIC POLITICS, TRADE ENERGY AND CIVIL SOCIETY OF THE ARAB GULF STATES. THE FIRST PUBLIC PROGRAM WAS HELD IN APRIL AND THE FULL STAFFING OF THE INSTITUTE WAS COMPLETED BY AUGUST 2015. IN ADDITION TO PUBLIC PROGRAMMING, AGSIW HELD A NUMBER OF ROUNDTABLE DISCUSSIONS AND BRIEFINGS TO BROADEN THE POLICY DEBATE AROUND ISSUES OF CONCERN TO THE UNITED STATES AND THE ARAB GULF STATES SUCH AS THE CONFLICT IN SYRIA AND THE WAR IN YEMEN. THE BOARD OF DIRECTORS APPOINTED A PRESIDENT AND THE INSTITUTE EMPLOYED AN ACCOMPLISHED FORMER DIPLOMAT AS THE EXECUTIVE
